Enrique Camacho Beltrán is a level-one national researcher at CONACYT (Mexico). His work in the area of international ethics explores the moral and philosophical arguments surrounding borders and immigration policy. His research covers a range of topics in contemporary political, social, and moral philosophy, such as the morality of discrimination and anti-corruption institutional policies.

Nicole Hallett is an associate clinical professor of law and director of the Immigrants' Rights Clinic at the University of Chicago Law School. She received a JD from Yale Law School and an MS in refugee and forced migration studies from the University of Oxford.

Tony Payan, PhD, is the Françoise and Edward Djerejian Fellow for Mexico Studies and director of the Center for the United States and Mexico at Rice University's Baker Institute for Public Policy. He is also a professor of social sciences at the Universidad Autónoma de Ciudad Juárez in Mexico. Between 2001 and 2015, Payan was a professor of political science at The University of Texas at El Paso.

Payan's research focuses primarily on border studies, particularly the U.S.-Mexico border. His work centers largely on issues of borderlands as areas of habitation, including the conditions that affect life in liminal spaces. Payan earned a BA in philosophy and classical languages from the University of Dallas and an MBA from the University of Dallas Graduate School of Management. He received a doctorate degree in international relations from Georgetown University in 2001.

Angela Remus is a JD student at Yale Law School and the Editor-in-Chief of the *Yale Journal of International Law*. She holds an MS in Refugee and Forced Migration Studies from the University of Oxford and a BA from the University of Rochester.

Jorge Santibáñez is the founder and president of Mexa Institute. He is a human migration scholar and, more specifically, an expert on Mexican communities in the United States. Dr. Santibáñez's migration expertise has led to collaborations as a consultant with the governments of Mexico, Spain, and France, as well as organizations such as the United Nations, the Inter-American Development Bank and the World Bank. Dr. Santibañez served as president and researcher at the Colegio de la Frontera Norte (COLEF), and as a public servant in Mexico as the head of the Unidad de Planeación y Evaluación de Políticas Educativas (Educational Policy Planning and Evaluation Unit) of the Secretaría de Educación Pública (Ministry of Public Education).

Dr. Santibáñez has taught classes and given lectures at institutions such as the Colegio de México, L'Institut d'Etudes Politiques de Paris, Universidad del Rey Juan Carlos, the University of California, the University of Southern California, New York University, the American University, and others. He has written editorials for print media, radio, and television. Dr. Santibáñez holds a degree in mathematics from the Universidad Nacional Autónoma de México, and a doctorate in mathematics, probability, and statistics from the Université Louis-Pasteur in Strasbourg, France.

Arcelia Serrano is an economist by training with a graduate degree in regional development. She specializes in migration, education, and labor markets; and works on survey design and data processing, and analysis of Mexican and U.S. public databases. In Mexico, she worked both as an academic and public servant in charge of the Dirección de Análisis de Información y Estudios de Política Educativa (Office of Information Analysis and Education Policy Studies) of the Secretaría de Educación Pública (Ministry of Public Education). In the United States she works with non-profit organizations on behalf of Mexican and Hispanic communities.

Camelia Tigau holds a PhD in social and political sciences (2007) and a master's in communication (2004) from the Universidad Nacional Autónoma

de México (UNAM). She also studied journalism and communication at the University of Bucharest and the schools of journalism in Utrecht (Holland) and Aarhus (Denmark).

Since 2009, she has worked as a researcher on skilled migration at the Center for Research on North America (CISAN) at the UNAM. She also teaches graduate and undergraduate classes at the Faculty of Social Sciences and Political Sciences at the same university.

She has also authored numerous articles and book chapters, mainly on migratory policies regarding North America and Mexico-U.S. relations. Verea is currently a member of various collegiate bodies, academic hiring advisory committees, and national and foreign editorial boards. She was awarded the Juana Ramírez de Asbaje Prize by the UNAM the first year it was given, in 2005.
